Military Equipment Annual Report 2023

INTRODUCTION

On September 30, 2021, Governor Gavin Newsom signed into law Assembly Bill 481 (AB 481) requiring law enforcement agencies to have a military equipment policy approved by the City Council prior to requesting, seeking funding, acquiring, or using military equipment. Assembly Bill 481 allows the governing body – the City Council – to approve the policy within its jurisdiction only if it determines that the military equipment, as defined by AB 481 meets specific standards. In 2022, City Council adopted an Ordinance No. 1703 establishing a Military Equipment Use Policy per AB 481.

The Military Equipment policy requires the Novato Police Department to publish an Annual Military Equipment Usage Report. Per Government Code §7072, the annual report must include the following information:

- A summary of any complaints or concerns received concerning the military equipment.
- The results of any internal audits or information about violations of the military equipment use policy. This includes any actions taken in response.
- The total annual cost for each type of military equipment, including acquisition, personnel, training, transportation, maintenance, storage, upgrade, and other ongoing costs, and from what source funds will be provided for the military equipment in the calendar year following submission of the annual military equipment report.
- The quantity possessed for each type of military equipment.
- If the law enforcement agency intends to acquire additional military equipment in the next year, the quantity sought for each type of military equipment.
- A summary of how the military equipment was used and the purpose of its use.

WHAT IS DEFINED AS MILITARY EQUIPMENT:

As defined by AB 481 and Government Code §§ 7070, "Military equipment" means the following:

- 1. Unmanned, remotely piloted, powered aerial or ground vehicles.
- 2. Mine-resistant ambush-protected (MRAP) vehicles or armored personnel carriers. However, police versions of standard consumer vehicles are specifically excluded from this subdivision.
- 3. High mobility multipurpose wheeled vehicles (HMMWV), commonly referred to as Humvees, two and one-half-ton trucks, five-ton trucks, or wheeled vehicles that have a breaching or entry apparatus attached. However, unarmored all-terrain vehicles (ATVs) and motorized dirt bikes are specifically excluded from this subdivision.
- 4. Tracked armored vehicles that provide ballistic protection to their occupants and utilize a tracked system instead of wheels for forward motion.

- 5. Command and control vehicles that are either built or modified to facilitate the operational control and direction of public safety units.
- 6. Weaponized aircraft, vessels, or vehicles of any kind.
- 7. Battering rams, slugs, and breaching apparatuses that are explosive in nature. However, items designed to remove a lock, such as bolt cutters, or a handheld ram designed to be operated by one person, are specifically excluded from this subdivision.
- 8. Firearms of .50 caliber or greater. However, standard issue shotguns are specifically excluded from this subdivision.
- 9. Ammunition of .50 caliber or greater. However, standard issue shotgun ammunition is specifically excluded from this subdivision.
- 10. Specialized firearms and ammunition of less than .50 caliber, including assault weapons as defined in Sections 30510 and 30515 of the Penal Code, with the exception of standard issue service weapons and ammunition of less than .50 caliber that are issued to officers, agents, or employees of a law enforcement agency or a state agency.
- 11. Any firearm or firearm accessory that is designed to launch explosive projectiles.
- 12. "Flashbang" grenades and explosive breaching tools, "tear gas," and "pepper balls," excluding standard, service-issued handheld pepper spray.
- 13. Taser Shockwave, microwave weapons, water cannons, and the Long-Range Acoustic Device (LRAD).
- 14. The following projectile launch platforms and their associated munitions: 40mm projectile launchers, "bean bag," rubber bullet, and specialty impact munition (SIM) weapons.
- 15. Any other equipment as determined by a governing body or a state agency to require additional oversight.
- 16. Notwithstanding paragraphs (1) through (15), "military equipment" does not include general equipment not designated as prohibited or controlled by the federal Defense Logistics Agency.

CONCERNS AND AUDITS

All use of force incidents are promptly and thoroughly reviewed by assigned supervisors and Watch Commanders. Reviews and audits provide opportunities to reflect on conduct, policies and procedures, legislation, and best practices within the policing profession Audits may also highlight opportunities for future improvements and can assist in evaluating practices related to training and daily operations.

During the 2023 reporting period, no violations were discovered. Officers were found to be operating in a manner which met or exceeded department and community expectations. Additionally, the Novato Police Department did not receive any complaints or concerns related to the use of this equipment.

PROJECTED MILITARY EQUIPMENT ACQUISITION

Currently, the Novato Police Department does not intend to acquire any new military equipment as defined by AB 481. The only related purchase will be the acquisition of additional ammunition to replenish stock used during training. Any future attempt to obtain new equipment will include adhering to procedures set forth in the Government Code and our Military Equipment policy; this includes a public hearing and City Council approval prior to acquisition. Department inventory and all costs associated with the use of this equipment is consistent with the Military Equipment inventory list, policy, and department budget previously approved by the City Council.

CONCLUSION

The Novato Police Department takes great care to regularly evaluate our equipment needs and only retain tools deemed as military equipment that help safeguard our community and employees. In addition, we frequently train with these tools to maintain proficiency and understanding of capabilities. We recognize the importance of using the most appropriate tool under evolving circumstances, always with the intent to bring the situation to peaceful resolution and significantly reduce the likelihood of injury to those involved.

SUMMARY OF USE:

1. Novato Police Department Case # NPD23-948

Summary of Incident: Domestic Violence/ Assault with a Deadly Weapon

On March 17, 2023, patrol officers responded to the report of a domestic violence incident involving a weapon. The victim was able to flee the residence. The suspect, who had a criminal history and possibly armed with a machete was initially not located. ARV was used to safely approach the residence.

2. Novato Police Department Case # AAR23-01

Summary of Incident: Outside Agency Assist (Sonoma County Sheriff's Department)

On March 31, 2023, Crisis Response Unit served a search warrant at a residence in Novato in relation to a homicide which took place in Sonoma County. The suspect was taken safely into custody and the residence was searched.

3. Novato Police Department Case # NPD23-2258

Summary of Incident: Suicidal Subject

On June 17, 2023, patrol officers responded to the report of a suicidal subject who had seriously injured himself with a knife. The subject had several firearms registered to him. Officers convinced the subject to exit the residence and took him to get the help he needed. The ARV was used to safely approach the residence.

4. Novato Police Department Case # NPD23-2624

Summary of Incident: Homicide

On July 14, 2023, patrol officers responded to the report of a shooting at a residence. Officer determined a subject had been shot multiple times and was deceased. The suspect was initially outstanding. The ARV was used to safely approach the residence and take the homicide suspect into custody without incident.

5. Novato Police Department Case # AAR23-03

Summary of Incident: CRU Activation for Arrest of Attempted Murder Suspect

On September 13, 2023, Crisis Response Unit was activated to assist with the arrest of suspects wanted in connection with an attempted homicide in San Rafael. CRU-SWAT located and apprehended the suspects without incident. SWAT then conducted a search warrant at the suspect's residence. The ARV was used during the arrest.

6. Novato Police Department Case # NPD23-3631

Summary of Incident: CRU Crisis Negotiations Team Activation for Arrest of Barricaded Assault with a Deadly Weapon suspect

On September 27, 2023, Crisis Response Unit was activated to assist with arrested an assault with a deadly weapon suspect who threatened an on-duty Novato Fire District Battalion Chief with an axe. The subject barricaded himself in a residence. The CRU-Crisis Negotiations Team successfully negotiated his safe surrender with no injuries to the officers or subject involved. No force was used. The ARV was used to safely approach the residence.

7. Outside Agency Assist- SRPD# 23-8089

Summary of Incident: ARV used to arrest suspects involved in vehicle pursuit

On December 29, 2023, San Rafael PD and CHP initiated a vehicle pursuit of a stolen RV. The vehicle initially fled, but eventually stopped at the entrance to Novato Community Hospital. The driver and occupants refused commands to exit the vehicle, but eventually came out of the vehicle and taken into custody without incident. The ARV was used to protect officers which they convinced the subjects to exit the vehicle.
