

# PROTECTING SERVICES FOR SAFETY AND QUALITY OF LIFE

The City of Novato is working to protect the essential services that directly contribute to safety and quality of life in the community.

#### **Repairing Potholes and Maintaining Parks**

Novato maintains over 300 miles of aging and deteriorating local streets and roads as well as sidewalks, parks, recreation facilities, storm drains, and other public infrastructure.

#### Rapid 9-1-1 Emergency Response

Novato's police officers patrol neighborhoods and crime prevention services protect public safety. Emergency services personnel prepare for disasters and emergencies like wildfires, earthquakes, and other emergencies.

#### **Growing Budget Deficit**

For several years, the City has experienced a growing budget deficit. The deficit is projected to continue to grow, relying on emergency reserves to maintain critical city services.

## **Local Funding for Local Needs**

To protect essential city services, the City Council is considering placing a measure on the November ballot to increase Novato's local sales tax, with 100% of the funding remaining in Novato for local services. If approved by local voters, Novato's local sales tax rate would be increased by up to 0.75%, adding 7½ cents to a \$10 purchase, which would be paid by anyone shopping in Novato, including visitors from other communities. With this increase, Novato's sales tax rate would be at or below the rates in neighboring cities like San Rafael and Petaluma. Essential purchases like groceries, medical & dental services, utilities, and prescription medicine are exempt from sales tax, helping to ensure the cost is not a burden to residents on fixed or limited incomes.

### Locally controlled revenue could be used to:



Fix potholes and maintain city streets



Maintain 9-1-1 emergency response and public safety



Attract and retain small businesses



Maintain parks and recreation programs and facilities



Reduce the risk of wildfires







## **Fiscal Accountability Protections**

Any proposal to enhance local funding would include strict fiscal accountability protections, including:

- All funds must stay in Novato for local services only and cannot be taken by the State, the County or other agencies; and
- All funds would be subject to independent oversight, audits, and mandatory public spending disclosure.
