VI. SUBCOMMITTEE REPORTS

A. Island Adoption – Goals & Objectives

1. Subcommittee Meeting Report & new language for agreement Language for the agreement was discussed. Ed wants page numbers on the pages. He handed out three packets this week to people interested in adopting islands. It is not user friendly as it is. The packet has 14 pages and is confusing. Discussion of some of the forms not really being fully relevant to adopting an island, but these are standard forms the city requires of all volunteers. Some of the information in the packet may be applicable to an employee, but is not necessary for island adoption. The enrollment process must be simplified, and not be onerous. Perhaps they don't need to receive *all* the pages at once. Some sections can be given later, for example the Seed Money request. Staff will review the simplification recommendations with the city and get back to the committee. The cover letter doesn't say "upon approval" a sign will be provided. Staff responded that anyone who fills out the agreement will be approved. The packet does state that the person/entity does have to get approval of what they plan to do with the island.

2. Pacheco Valley update

Volunteers finished weeding the end of the slope up against the pedestrian path to open space and took out an old bike rack. The plants are blooming from the sun and water they are receiving. Volunteers may talk to their HOA's about getting funds to do more.

3. Streetscape Committee island update

Bill, Ed and Len put the sign in place. The sign faces more easterly and isn't visible to cars coming west on Diablo. Consider having two signs on some islands – each facing opposite directions. Other islands, could have a sign on each end. There was a discussion on number of signs and ideal placement on islands. There is not perfect spot – each situation is different, traffic-wise. There is still a problem with drainage – too much water pooling – this is being investigated.

4. Siemans adoption of former Republic island

Suggestion to remove phone # once an island is adopted. Some members think having the number on the signs all the time allows for the possibility of more people to inquire about adoption. Others feel the viewer will think the number is for the entity that adopted the island. Agreed to monitor how many calls are received at the number for the next month.

Siemans: The city staff cleaned up the island and now Siemans will maintain it, but they won't be doing any improvements.

5. Green Point Nursery Island

No work will commence until intersection work is completed – June/July.

6. Bahia Islands update

Len spoke to resident Bob Burley who says the community is enthusiastic about the project. Marcia met with Stuart, Bob and Harold at the site. They are working on the plants to select. There seems to be some discord with one of the members of the Bahia group. But they want to go forward. Marcia provided an outline of what they should be thinking about and recommended they consult with Bill Johnson. Water has been brought to the island, but they need to implement an irrigation system themselves.

7. Ignacio Rotary

The island is not looking great. No one has been in contact with the group yet. **Len will make contact with them through Pauline Stuber.**

8. Ignacio Sunset Island

Christina McNair wants to adopt that island. She has been given the packet of information.

9. James Black Circle update

Robin Burgess has adopted the island and had it cleaned up, the sign has been placed. No plans have come forward yet.

10. Friends of Novato Creek island

Letter has been sent to them and no response received, sign will be removed and the island is now available.

Ed reported that the Safeway manager is interested and once he has a packet from the committee he will discuss it with the employees.
