## NOTICE OF COMPLETION & AVAILABILITY

Notice is hereby given that the City of Novato ("City"), acting as lead agency, has completed a Draft Environmental Impact Report (DEIR) for Novato's Draft Housing Element 2007-2014. The Draft Housing Element represents the City's approach to meeting the current and near-term housing needs of the community as assigned by the State of California through its Regional Housing Needs Allocation (RHNA). The Draft Housing Element contains goals, policies, and implementing programs intended to support the provision of range of housing opportunities in Novato, in particular housing for persons in the low and very low income categories. The Housing Element update process includes amending the Novato General Plan, the Downtown Novato Specific Plan, the Novato Zoning Ordinance, and the Master Plan and Precise Development Plan for the Ignacio and Hamilton Industrial Parks to implement Draft Housing Element Programs 9.B, 9.E, and 12.A. These amendments include the establishment of an Affordable Housing Overlay District, which would be assigned to five (5) housing opportunity sites located at: (1) 1787 Grant Avenue, APNs 141-201-48 & 141-201-12; (2) Landing Court, APN 153-162-59; (3) Redwood Boulevard, APN 125-202-18 (4-acre portion of a 39.92 acre site); (4) 7506 Redwood Boulevard, APN 143-011-08; and, (5) 1905 Novato Boulevard, APN 140-011-66.

The DEIR identifies several potentially significant environmental impacts resulting from implementation of the Draft Housing Element. The potentially significant impacts were noted in the following impact categories addressed by California Environmental Quality Act (CEQA): Air Quality, Biological Resources, Cultural Resources, Hydrology/Water Quality, Noise, and Transportation/Circulation. All potentially significant impacts have been assigned mitigation measures, which reduce these impacts to a less than significant level.
