CONTINUED ITEMS:

3. BEL MARIN KEYS INDUSTRIAL PARKS: WHITE PAPER TOPIC (BB)

Provide a recommendation to the City Council regarding land use restrictions for the Bel Marin Keys Industrial Parks for inclusion into the Draft General Plan.

This is a joint session with the Economic Development Committee.

No environmental review is required. This information about Bel Marin Keys will be incorporated into the General Plan update process and an environmental review will be prepared for that document.

Community Development Director Bob Brown presented the discussion topic on the Bel Marin Keys Industrial Park and whether changes to the allowed uses should be considered as part of the update of the General Plan.

There were no members of the public who spoke on this topic.

There was a unanimous recommendation by members of the Planning Commission (Jordan, Dawson, Strauss, Tiernan) and members of the Economic Development Advisory Committee (Williams, Pelham, Thomas) to endorse the following Policy Options of the Bel Marin Keys White Paper:

- Maintain the intention of limiting personal service, retail and restaurant uses to serve
 employees of the industrial parks, but modify the Master Plan language to better define
 a list of allowable uses and establish size limitations,
- Modify the Master Plan language pertaining to retail sales to allow minor retail uses as a minor component of a larger, permitted business.
- Modify the Master Plan language to allow automotive uses in the Hamilton Industrial Park as a permitted use.

NEW ITEMS: None

GENERAL BUSINESS:

Planning Manager Dunn let the Planning Commission know that the City Council will be interviewing four prospective candidates for the Planning Commission on March 4, 2014, and may consider an appointment of two candidates on March 18, 2014.

Community Development Director Brown informed the Planning Commission that the General Plan Existing Conditions report would be released soon. This document provides a snapshot of the City. Staff is now working on a review the existing policies and programs of the various elements of the General Plan.

David Parisi, a local transportation consultant, is being considered to assist with the streetscape planning for the North Redwood Corridor process. He will be guiding the public and the Design Review Commission through the next steps of this process. This process should begin in May 2014.

There will be a Community Workshop for the North, North Redwood Boulevard area that incorporates the topics of land use, traffic modeling, and potential traffic improvements in this area. This workshop is intended for early June 2014.

Future White Paper topics are: Downtown Parking options and Downtown zoning; Sea Level Rise, and the City's Climate Action Plan; the Urban Growth Boundary; the Hillside and Protection Ordinance, and Traffic Level of Service (LOS).
