2. WATER AVAILABILITY WHITE PAPER (BB, AL)

Provide initial direction regarding potential policy considerations to aid staff in preparation of the Draft General Plan.

No environmental review is required. This information will be incorporated into the General Plan update process and an environmental review will be prepared for that document.

Community Development Director Brown gave a brief summary of the background and summary points about this white paper, and Andrew Linford, Coro Fellow, presented the white paper on Water Availability and Conservation.

The Commission had questions relating to: differences in average consumption of water between single family homes and multi-family homes; how much water Marin Municipal Water District receives from the Sonoma County Water Agency; and how retrofit of plumbing fixtures affects water conservation. The Commission also raised issues regarding: water conservation efforts remain critical; and the delivery of water to the City is relatively secure.

The public hearing was opened, and closed, as no public attended.

Chair Jordan indicated that overall, the City is in good shape with a reliable water supply and strong conservation efforts. Commissioner Wernick voiced concern over mandating a retrofit policy, whether during a resale inspection or as new language in the Building Code, for a major remodel or tenant improvement. Such a policy, that requires toilets or faucets to be upgraded for more water efficient products, places a cost burden on the homeowner. Commissioner Strauss endorsed Commissioner's Wernick's remarks and stated that no recommendation regarding the options presented was needed from the Planning Commission until there was a real showing of compelling needs. No motion was made or seconded regarding this statement.

M/S, Tiernan/Havel, to recommend option #4 for the Council to consider (make older homes upgrade the plumbing fixtures for a major remodel or tenant improvement project). Ayes: 2 (Havel, Tiernan); Noes: 4 (Dawson, Jordan, Strauss, Wernick). This motion failed.

Community Development Director Brown indicated he would inform the City Council at its June 17 meeting about this discussion of the Commission.

GENERAL BUSINESS:

Planner Dunn informed the Commission about the future Agendas and of the status of the Planning Commissioner recruitment.
