- E 1 Introduction of Amber Wright, ROIC's new Director of Marketing and Leasing for Northern California. Ms. Wright reviewed her experience with the Santa Row development in San Jose and said she would be aggressively seeking tenants for their Novato Lifestyle retail center.
- E 2 Life Science Marketing & Job Recruitment Campaign update Report. Following a brief introduction of Ms. Smith by Mr. Stewart Ms. Smith outlined some of the planned activities and kick-off event at the upcoming Bio conference in San Diego.

- E-3 Selection of two Novato Life Science companies Mr. Stewart reported that the Governor's office had selected Ultragenyx and XCell to be award \$2.02 million in state income tax credits for agreeing to hire 188 new employees. Mr. Stewart also noted that those 188 new life science jobs would create an additional 122 jobs and increase the local economy by \$86 million annually.
- E-4 Novato's Retail Leakage increased to \$250 million in 2013: Mr. Stewart reported that according to the information provided by MuniServices Novato's retail leakage had increased from \$170 million in 2011 to \$250 million in 2013.
