**CEQA: EXEMPT FROM THE REQUIREMENTS OF THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA), PURSUANT TO CEQA GUIDELINES SECTION 15303(e)**

Conduct a public hearing to consider approval of the Canyon Green Fence Plan dated April 8, 2014, Attachment 2, which includes an alternate fence design, Type B: Good Neighbor Fence, for yards oriented towards Canyon Green Loop and the private park amenity (The Green) for Lots 1 through 10, and find that approval of a revised fence design is exempt from the requirements of the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15303(e).
