P2015-023; USE PERMIT
CEQA CATEGORICALLY EXEMPT: SECTIONS 15301 & 15303
7430 REDWOOD BLVD, SUITE D, NOVATO

Conduct a public hearing to consider granting a use permit for the operation of a religious facility in the existing building at 7430 Redwood Boulevard, Suite D. The space would be used for an office to run the day-to-day operations of the facility, with Friday evening and Saturday Morning worship services and smaller weekly meetings of different segments of the organization. Larger events are held elsewhere.

The proposed project is exempt from the requirements of the California Environmental Quality Act (CEQA) and the City of Novato Environmental Review Guidelines pursuant to CEQA Guidelines Sections 15301, Existing Facilities, and 15303, New Construction or Conversion of Small Structures.

To appeal a final decision of the Zoning Administrator, a written letter of appeal and the required appeal fee must be filed with the Community Development Department within 10 calendar days of the decision. The appeal letter must specifically state the basis for the appeal. Additional information on the appeal process can be found in Division 19.54 of the Novato Municipal Code.

If anyone wishes to challenge a project in court, they may be limited to raising only those issues they or anyone else raised at the public hearing described in this agenda or in written correspondence delivered to the Community Development Department at, or prior to, the public hearing.
