Conduct a public hearing to consider a formal recommendation to the Planning Commission and City Council on site design, circulation, and architecture for the development of 16 single family (55+) senior housing units on a 1.5 acre parcel known as the Senior Housing Triangle of the Hamilton Field Master Plan area; Assessor’s Parcel Number 157-860-03. The project includes an access drive, 16 public/guest parking stalls, and a bio-retention area to be constructed in an easement on an adjacent City-owned parcel, APN 157-860-04. Pursuant to Section 15063 of the California Environmental Quality Act, an environmental review will be prepared for the project based upon the Design Review Commission’s recommendation, which will be brought to the Planning Commission for a recommendation and City Council for action.
