1. McPHAIL'S COMMERCIAL OFFICE DEVELOPMENT (HG)

P2015-080; DESIGN REVIEW APN 153-220-16 & 19; 5400 HANNA RANCH ROAD

Conduct a public hearing to consider approving site design, landscaping and building architecture revisions for Buildings A (21,200sf, two story), B (24,000sf, single story), and C (14,400sf single story) of the McPhail's Office Commercial Development for a combined total of 59,600sf on a 4.9 acre vacant site located at the northeast corner of the interchange of Highways 101 and 37. The project, including a Mitigated Negative Declaration, a Master Plan, a Precise Development Plan and a Tentative Map, was initially approved in 2008. Based on the type of design changes proposed, pursuant to Section 15162 of the California Environmental Quality Act, no subsequent Negative Declaration will be prepared.
