Project Description	<p>The project involves requests for a general plan amendment, master plan amendment, precise development plan, tentative map, use permit, and design review to construct 31 for-sale residential condominiums (six affordable units) on a 2.7 acre site, including: eight three-story (34-feet high) buildings, one two-story building, and 79 on-site parking stalls. A use permit has been requested to allow the removal of contaminated soil from the project site.</p> <p>The City Council will consider taking action on a CEQA determination (noted below) for the project and a use permit to remove contaminated soil. The City Council will take no other action on the project at this time. Any subsequent action on the development permits noted above will be the subject of separately noticed public hearings.</p> <p>The project site is identified on a list of hazardous waste sites compiled by the Department of Toxic Substances Control pursuant to California Government Code 65962.5.</p>
California Environmental Quality Act (CEQA)	A revised Initial Study/Mitigated Negative Declaration (MND) and an errata were prepared for the project. Planning Commission Recommendation	The Novato Planning Commission, at its hearing of May 17, 2017, recommended the City Council adopt a Mitigated Negative Declaration for the project and approve a use permit allowing the removal of contaminated soil from the project site.
