

# MINUTES MULTICULTURAL COMMISSION MEETING

#### 1. CALL TO ORDER - Chairman Jacobs

Laurie Marshall invited the Commission to attend the Marin Singing Tree, an intergenerational, interracial, non-partisan project to explore and clarify values and strengths. Johnson Sr. Center, Marin City), August 4<sup>th</sup> (Mill Valley Community Center, Mill Valley), August 11<sup>th</sup> (Corte Madera Town Center Community Room, Corte Madera), August 18<sup>th</sup> (YMCA Youth Court Office, San Rafael), August 25<sup>th</sup> (Hill Community Room, Novato) and September 21<sup>st</sup> (TBD).

The 6-hour Multicultural Festival event was well-attended. Other suggestions were to relocate the festival to Miwok Park from downtown but it was noted that parking could become an issue.
