IV. CITIZENS' TIME TO ADDRESS THE COMMITTEE

Friends of Fairway Island adopted the median and were represented by Steve Grant who gave the committee a plan for restoration. Materials will be supplied by the neighbors and installed by their contractor. Steve Grant stated that they will have a fundraiser to come up with the funds on July 30th. He will return with a specific budget and a request for Streetscape funding for \$500.00. They will maintain the median.

Karen Strolia, Project Manager from Downtown Streets Team addressed the group about the work they have been doing with cleaning up the litter and trash in Novato. She talked about the benefits of the program and how partnering with the City of Novato is enabling the homeless members to become self-sufficient.

Waite introduced Veronica Brierley as the new staff support member to the committee.

Shigoli let the committee know that the Arc of San Francisco, will be sending a group of volunteers in July and would be performing clean up and debris pick up at designated park sites.

VI. COMMITTEE MEMBERS' COMMENT TIME

Basalla raised a concern about the irrigation at the downtown bus depot and how it's affected the rest of the medians on Redwood Blvd. She notified Public works and Russ Thompson inquired with Thompson Builders, the contractor in charge of the project. A plan of action to restore the medians to their original state, is yet to be determined.

Buder asked about the trees on Machin Ave. and if the Maintenance Division can address the bark and metal grate hazards. Shigoli stated that he would look into it.
