Re: Amending the Tobacco Retail License Ordinance

Dear Owners & Managers of stores, drug stores, mini-marts, gas stations and other businesses that sell tobacco or tobacco-related products:

The Novato City Council voted on Tuesday, January 31, 2017 to enact a Tobacco Retailing License (TRL) Ordinance that is currently scheduled to go into effect on January 1, 2018. We met with many of you on March 30, 2017 to discuss the TRL Ordinance and work together to amend two of the subsections of the ordinance. These changes and other amendments are included in a table on page 2 of this document.

We are writing to let you know that staff is returning to Council on December 5, 2017 to amend the ordinance to both incorporate the changes we agree to make and to update the implementation schedule.
