10 minutes	E-1: Welcome New Members	Staff Report. No action.	
New members, Meherdad Namiranian and Chase Maxwell, introduced themselves to the committee and provided their experience and backgrounds. Gosia distributed the resolution that governs the committee and requested the committee read through it so it can be discussed at the next meeting. She also provided a little history about the formation of the committee which was based on Measure B and was established to monitor the financial aspect and distribution of funds. All paving projects go through the committee and feedback is requested. They also provide support to PW regarding prohibition of excavation and issues going to Council.			
5 minutes	E-2: Brown Act Training Date	Staff Report. No action.	
Brown Act training will be held at 6pm on November 30 th at the Novato School District Auditorium on 7 th St. It will also be televised on channel 27. Not sure if watching, versus attending, will suffice.			
5 minutes	E-3: Parking in front of MTSC	Staff Report. No action.	
Ed initially brought up concerns with parking at this location- buses on Hill Rd, in front of MTSC, were pulling up on the sidewalk and parking buses illegally in the bike lane and sidewalk. A work order was created for our traffic engineer, Mary Jo, to investigate. The result- we have requested that the current handicap space in the turnout be removed; one of the sign poles will go away and the No Stopping Anytime and Loading Zone sign will be moved to another pole. We will also let transit agencies know that drivers cannot continue to park illegally in that location.			
5	E-4: Quest Church Development/ Johnson Street	Staff Report. No action.	

Gosia spoke to the planners who provided the configuration of the street for the planned development. The church driveway will stay. The developer has taken care of the Safe Routes to School access issue in the approved plan. A traffic study was done prior to planning. The planning staff (Hans) can answer any other specific questions related to this development.

Planning Manager, Steve Marshall, is overseeing this project. The plan has not changed since 2011. There is no connection to the 37, and the only connection to the 37 would be for emergency vehicles. EIRS are nearly complete, so it is not likely to be opened up for debate. There has not been much movement on the project, so there may be some changes or additions. Potential for environment impact reports to reopen, but making major changes with 37 link up is unlikely.
