Mark spoke about the Novato Blvd Widening Project meeting that he attended. Two plans were discussed showing both a 3 and 5 lane option. The 3 lane would allow for protected bike lanes. Petr stated that protected bike lanes are not guaranteed to be part of the project yet. Mark thought it would be helpful if BPAC weighed in on the project. Petr said there will be Class II bike lanes and sidewalks included in the scope of the project. There will be a staff presentation/recommendation at an upcoming Council Meeting and the council will provide guidance to staff on how to move forward. The public that attended the meetings, preferred the 3 lane option.

Mark made a motion that BPAC supports the 3 lane option versus the 5, and investigate the feasibility of some type of separation for the bike lanes.
