1. **RESOLUTION OF THE PLANNING COMMISSION RECOMMENDING ADOPTION OF A GENERAL PLAN AMENDMENT TO INCORPORATE THE LANDS OF GRANUCCI (290 GRANDVIEW AVENUE; APN 157-103-50) WITHIN THE CITY’S URBAN GROWTH BOUNDARY AND FINDING THAT INSTALLATION OF LEACH FIELDS IN THE STONE TREE GOLF COURSE PROPERTY IS CONSISTENT WITH THE BLACK POINT MASTER PLAN AND PRECISE DEVELOPMENT PLAN AND FINDING THAT THE PROJECT IS EXEMPT FROM THE REQUIREMENTS OF THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA), PURSUANT TO CEQA GUIDELINES SECTIONS 15303(A) AND 15304(F).**

Recommend to the City Council adoption of a General Plan Amendment to incorporate the Lands of Granucci (290 Grandview Avenue; APN 157-103-50) within the City’s Urban Growth Boundary and finding that installation of leach fields in the Stone Tree Golf Course property is consistent with the Black Point Master Plan and Precise Development Plan and finding that the project is exempt from the requirements of the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Sections 15303(a) and 15304(f).
