NEW ITEMS:

4. PROPOSED NEW CAPITAL IMPROVEMENT PROJECT (CB) NOVATO COMMUNITY GARDEN GENERAL PLAN CONSISTENCY REPORT

Consider providing a report to the City Council regarding whether a proposed new Capital Improvement Project to establish a community garden at the Lieb Property, 1521 Hill Road (APN 140-352-32), is consistent with the Novato General Plan.

Commissioners Tiernan and Weldon recused themselves from this item. Commissioner Tiernan is a member of the group advancing the community garden. Commissioner Weldon lives within 500-feet of the project site.

Deputy Public Works Director Blunk presented the staff report.

Commissioner Wernick referenced the City Council position on the community garden in 2017 and asked why a consistency review was not conducted sooner.

Deputy Director Blunk provided background information regarding conversations with Living Well Network regarding the community garden. A decision to formalize and document the project was made [based on City Council input] to work out responsibilities between the City and Living Well Network.

Commissioner Wernick asked if CEQA review would be performed on just the garden or full site.

Deputy Director Blunk said CEQA review would cover just the garden – there is no plan for the full site.

Commissioner Wernick referenced an Open Novato survey regarding the community garden - noted twenty-two respondents. Who is interested in gardening here?

Deputy Director Blunk stated he did not have that information and reiterated that General Plan consistency was the purpose of the hearing.

Vice Chair Gabriel inquired about the source of funds for the garden.

Deputy Director Blunk noted a variety of potential funding sources, including grants.

Chair Derby opened the item for public comment.

David Selzer noted his 10 year affiliation with Living Well Network and past efforts to establish a community garden. He expressed support for the community garden proposal at the Lieb property and commented on the benefits of the location.

Robert Bastione commented on his experience with gardening and his vision that a community garden will be a place of gathering for residents. He felt the proposal is consistent with the General Plan. He referenced Novato's history of agriculture. He recommended the Planning Commission follow staff's recommendation to adopt the resolution finding consistency with the General Plan.

Chair Derby closed the item for public comment and returned the matter to Planning Commission for deliberation.

Commission Wernick asked to confirm only personal cultivation would be allowed – no commercial.

Deputy Director Blunk confirmed personal cultivation only.

Commissioner Rao and Deputy Director Blunk exchanged comments; there is a gap in audio for the hearing and these comments cannot be confirmed.

Vice Chair Gabriel suggested having third party input from the UC Master Gardeners.

Mr. Bastione confirmed UC Master Gardeners have been contacted.

Motion/Second: Wernick/Gabriel to adopt the resolution reporting to the City Council that adding the community garden to the capital improvement program is consistent with the General Plan. Motion passed: 4-0 (Ayes: Wernick, Gabriel, Rao, and Derby) – Weldon and Tiernan recused and Dawson absent.
