



REQUEST

Receive a report on the history of the Multicultural Day event and consider opportunities to incorporate multicultural activities in current City events or consider partnership with other agencies with established events.

DISCUSSION

The City of Novato Multicultural Oversight Committee was formerly created January 25, 2000 and subsequently changed its name to the Multicultural Commission. In 2005, the Novato City Council approved the Commission to meet on an "as needed" basis. In 2007, the City Council approved a reduction in members from seven to five as well as the addition of "Advisory" to the name. The Commission has struggled to maintain membership and has had to cancel multiple meetings due to lack of quorum. Resolution 2018-85 approved by the City Council on November 13, 2018, reinstated the Multicultural Advisory Commission as a seven-member advisory body to the City Manager and City Council to "provide support on issues surrounding multiculturalism, diversity, hate crimes, and community awareness on issues involving any of the above…"

The inaugural Multicultural Day event was held in Miwok Park on April 29, 2006. The event was a collaboration between the Multicultural Commission, and leadership classes from Novato High and San Marin High. The Multicultural Commission worked directly with the teachers and students from each school to plan and implement the event which involved interactive booths featuring different community groups.

On November 28, 2006, the Novato City Council approved a proposal by the Multicultural Commission to support a similar event annually. However, the Multicultural Day event has experienced varying levels of attendance and support since the inaugural event in 2006. Due to scheduling conflicts and other factors, the event was cancelled in 2016 and 2018. The locations of events have varied and there has been discussion in consideration of partnering with other organizations to host a joint event.

Based on varying attendance levels and capacity of staff and the Commission, staff recommends that the Commission seek opportunities to collaborate or partner with agencies that already conduct these types of events. Additionally, the Commission can review the City's current activities and recommend additional multicultural aspects to be incorporated.

FISCAL IMPACT

The fiscal impact has not been determined and is dependent on the level of involvement. Anticipated costs include staff time, promotional materials, and supplies.

DISCUSSION

Not in Our Town (NIOT) was a project initiated in 1995 by The Working Group, an Oakland, California-based nonprofit strategic media company. NIOT is a "movement to stop hate, address bullying, and build safe, inclusive communities for all." The campaign uses film, social media, and organizing tools to help local community groups to stop hate. The City of Novato, Novato Police Department, and Novato Unified School District have co-hosted film screenings with speaker panels addressing various topics ranging from hate crimes to implicit bias.

The mission of the Multicultural Advisory Commission is to:

"act as a catalyst to encourage respect, understanding, and inclusion of all of Novato's diversity. The Commission seeks to enrich the lives of the community through courageous interpersonal dialogue, and strives to build a safe and strong community through group and individual interaction as well as outreach, activities and education."


