**P2019-028; USE PERMIT** 

CEQA CATEGORICALLY EXEMPT: SECTION 15301 APN 151-022-09; 1461 SOUTH NOVATO BOULEVARD

Consider a Use Permit to allow for the operation of the Alpha Kids Academy at the existing Quest Church Facility located at 1461 S. Novato Boulevard (APN

151-022-09). The school proposes to operate from 7:30 AM until 6:00 PM and will provide pre-school services for up to 35 children throughout the day. To appeal a final decision of the Zoning Administrator, a written letter of appeal and the required appeal fee must be filed with the Community Development Department within 10 calendar days of the decision. The appeal letter must specifically state the basis for the appeal. Additional information on the appeal process can be found in Division 19.54 of the Novato Municipal Code.

If anyone wishes to challenge a project in court, they may be limited to raising only those issues they or anyone else raised at the public hearing described in this agenda or in written correspondence delivered to the Community Development Department at, or prior to, the public hearing.
