CEQA EXEMPT: SECTION 15061(b)(3) and BPC 26055(H)

Hold a public hearing and consider adopting a resolution recommending the City Council amend Novato Municipal Code Chapter 19 to establish regulations for permitting of commercial cannabis activities in the City. Those activities could consist of cultivation, manufacture, distribution, testing and sales of cannabis and cannabis-related products.
