Gosia presented the methodology at the last meeting and went on to explain the street selection process for the upcoming annual pavement rehabilitation project. She created a map showing candidate streets; she selected them based on functional classification (federal funding allows paving of arterials and collectors but not residential streets). The 2<sup>nd</sup> selection is based on PCI (pavement condition index) whatever is under 75 shows on list she handed out. She drove all the streets to inspect and grouped them by treatments being recommended. Federal grant has an obligation deadline of January 31, 2020 which requires design to be finalized prior to that date.
