

## IV. CITIZENS' TIME TO ADDRESS THE COMMITTEE

- Andrea Kiesel Had attended a Team Up To Clean Up event and is interested in joining the Streetscape Committee.
- Andrea Kiesel's concerns are lack of responsibility of business owners, lack of maintenance at bus kiosks, and the cleanliness of sidewalks.
- Andrea Kiesel believes there is a lack of pride in the city and would like to start
  with getting kids involved in beautifying the city, with a contest with posters.
  Andrea Kiesel believes that the next generation of kids are activists and can help
  them to be aware of their city.
- Susan Stompe Addressed 3 things. One is an update about trees from Caltrans and will reach out to Gretchen Schubeck.
- Susan tompe had suggested to come up with appropriate trees and sites with the school district and open space and where to put them.
- Susan Stompe stated that she would like to have a plan to identify trees before planting them.
- Susan Stompe would like the committee to recommend 75 Rowland Blvd as a possible Business Landscape Recognition nomination.
- Stompe stated she would help volunteer with Clean & Green Day if it happens next year. The committee stated they would have more conversation about it.

## V. STAFF CONCERN

- Maggie Rufo Addressed 2 islands that are adopted at Redwood Blvd and So. Novato Blvd. The other island is maintained by Sharon McCloskey. Rufo stated she would like to get amendments and compost and a get a layer of mulch on the 2 islands to suppress the weeds. She would also like to get some native plants.
- Maggie Rufo stated the plants in the median need to be trimmed low for visibility.
- Basalla stated that maybe the city could provide the soil amendments and chips and the Streetscape committee could pay for the plants.
- Rufo stated she will keep trying to be the adopter and Shigoli asked what she would like the sign to read on the island.
- Shigoli stated that the Streetscape Committee had a transfer of funds and now has

- Hanna stated that for Publicity, under Subcommittee Reports to put Michael Furry as the liaison, and to change Public Outreach to Publicity & Public Outreach.
- Basalla stated everyone on the committee should be involved with the Adoptan-Island program.
- Temple asked what happens if an island is not maintained. Basalla and Hanna stated that they all were in charge of an island to be sure it was maintained.
- Shigoli stated that they Maintenance crew can put the signs in an island once adopted.
- Hanna asked who the liaison would be for Finance and Shigoli stated they are
  working on streamlining how to get the Streetscape Report without having to go
  through too many people.
- Temple stated that she will work with Gretchen on removal of empty newspaper stands around Novato.
- Hanna stated that in the future the committee can start a Clean Business
   Program like Clean Marin where they recognize a business is doing a good job and give them a decal for their window.
- Basalla would like to reach out to businesses on streets in addition to those on Grant Avenue and Hamilton.
- Temple stated that when she does approach a business, that maybe the Downtown Business Association and the Novato Garden Club could help with seed money along with the Streetscape Committee to encourage people. The Streetscape can plant it themselves or we can help contribute to the planters.
- Hanna asked Brierley to update the Streetscape Roster.
