F. PRESENTATIONS

F.1. Presentation by Senior Supervisor Debbie Younkin and Program Coordinator Tiffany Haley from the City of San Rafael on the Hamilton Pool Summer 2019 Recap.

Information in the presentation included a total of 478 hours of lap swim hours and 664 total number of hours of public swim. There were a total of 80 party rentals booked in 2019. The number of group swim lessons decreased from 535 in 2018 to 486 in 2019. Private lessons were also slightly down from 157 in 2018 to 131 in 2019. Unexpected activity pool closures were a result of electrical issues May 13-June 10, mechanical issues August 13-22 and the main pool was closed due to heater failure September 16-20.
