 two-hour cut-off, including during and after the meeting will be collected and placed in the public
 record. Mail will not be read during the meeting.
- **Spoken public comments.** Members of the public may provide public comments via telephonic participation. To do so,
 - 1. Call the WebEx phone number at (415) 655-0002
 - 2. Enter the meeting number (access code): 146 289 9427
 - 3. In order to provide public comment over the phone, press Star (*) Three (3) when prompted by the Chair at the beginning of public comments.

- 4. You will hear a message stating "You have raised your hand to ask a question. Please wait to speak until the hosts calls on you."
- 5. When the host unmutes your line, you will receive a message: Your line has been unmuted. This will prompt you to begin your public comment.
 - You have three (3) minutes for your comment or the amount of time the Mayor has allotted each caller.
- 6. After you make your comment, the host will mute your call. You will hear "Your line has been muted."

Notification at least 48 hours prior to the meeting will enable the City to make reasonable accommodation to help insure accessibility to this meeting.

The Board, Committee, Commission may direct that the item be referred to the Staff Liaison for action or may schedule the item on a subsequent agenda.
