- **Spoken public comments.** Members of the public not physically present at the meeting may provide public comments via telephonic participation. To do so,

- 3. In order to provide public comment over the phone, press Star (*) Three (3) when prompted by the Mayor/Chair at the beginning of public comments.
- 4. You will hear a message stating "You have raised your hand to ask a question. Please wait to speak until the hosts calls on you."
- 5. When the host unmutes your line and addresses you as "caller," you will receive a message: Your line has been unmuted. This will prompt you to begin your public comment.
 - You have three (3) minutes for your comment or the amount of time the Mayor/Chair has allotted each caller.
- 6. After you make your comment, the host will mute your call. You will hear "Your line has been muted."

In compliance with the Americans with Disabilities Act, if you need special assistance to participate in this meeting, please contact the Staff Liaison at (415) 899-8975. Notification at least 48 hours prior to the meeting will enable the City to make reasonable accommodation to help insure accessibility to this meeting. 
