Director Parker added that the City has offered the Acting Building Official as well as a building inspector to speak to the participants as part of the program.

Commissioners gave positive feedback on the State of the City address by City Manager McGill.

Commissioner Mahoney expressed positive impacts on businesses with the SMART train now stopping Downtown.

Chair Russell asked about the possibility of electric bikes or scooters available for rental at the downtown station, known as "Last mile options." Director Parker noted that staff has been researching possibilities and will provide a follow-up at a future meeting.

Ex-Officio Karell updated the commission on upcoming workshops offered by the Marin Small Business Development Center (SBDC).

 Director Parker provided a synopsis of the options presented to City Council.
