E. GENERAL BUSINESS

E-2: DISCUSSION ITEMS:

E-2.1: FINANCE ACTIVITES UPDATE – Finance Director Amy Cunningham

• FY 18/19 CAFR – All of the requested information has been provided to the Auditors, with staff expecting to receive follow up questions soon. If any FY 18/19 surplus exists, Council will be asked to take action to assign it to reserves once the audit is complete.

• FINANCE RECRUITMENTS – There has been no success with the recruitments for the Accounting Supervisor and the Accountant Analyst positions. A proposal will be considered by the Council on September 22, 2020 to change the Accounting Supervisor position to a Senior Accountant position and the Accountant Analyst position to an Accountant I/II position to better align classifications/responsibilities with industry standards.

Chair Rafelina Maglio asked how the City is backfilling the five (5) Finance Department vacancies. Staff advised that a combination of consultants and contractors have been able to provide assistance in some areas.

CARES ACT - COVID-19 EMERGENCY REIMBURSEMENTS

The City has already received \$221,022 of the \$663,066 funds allocated from the CARES ACT. These funds will reimburse the General Fund for expenses incurred for COVID related activities.

PUBLIC COMMENT REGARDING FINANCE UPDATE-NO PUBLIC COMMENT

E-2-2: FY 20/21 BUDGET UPDATE – Finance Director Amy Cunningham

Staff is working on the FY 19/20 budget revise report for Council consideration on September 29, 2020. Online sales tax has been helpful in bridging the gap for lost sales tax revenue at brick and mortar locations. Auto sales have been down about 20-21%. We will not know the impact of the Business Licenses until the beginning of the calendar year when most businesses renew their license. TOT revenue remains in flux as well.

The City has approximately 30 full-time employee vacancies and will be making recommendations on freezing and eliminating some positions to reduce the deficit as part of this report. Changes in operations due to COVID have generated savings in professional services, training, and travel.

Vice Chair Mark Milberg asked about how the position changes will affect full-time employees. The goal is to reduce the deficit and preserve services where financially appropriate, without having to lay off employees unnecessarily. Finance Director Amy Cunningham explained how staff was also looking for opportunities to reconfigure positions in ways that could save money, e.g. Senior Planner to a regular Planner, and still deliver services.

In February the usual mid-year budget review will take place, this is an additional opportunity for staff to review revenues and expenditures and make recommendations for any other needed budget adjustments.

City Council approved Measure Q (Transient Occupancy Tax-TOT) to be included on the November 3, 2020 ballot. If passed, this Measure will increase TOT revenues to the City, the expectation is approximately \$200K in additional funds would be received in FY 20/21.

E-2-3: REVIEW MEASURE F ANNUAL REPORT

Committee member Regina Bianucci Rus provided a report on Measure F and shared a draft Power Point presentation. She stated that \$22.6 million has been received and she will provide a graph of the funded projects.

The Committee members provided feedback and suggestions on the presentation and thanked Committee member Bianucci Rus for her work.

Chair Rafelina Maglio and Committee member Caitrin DeVine suggested formation of a Subcommittee to help staff with the Measure F report. The Committee agreed to appoint them to the subcommittee/working group.

F. COMMITTEE / STAFF COMMENTS

Committee member Tim O'Connor would like to update the Fiscal Sustainability Plan. Vice Chair Mark Milberg is also in favor updating the plan.

Committee member Cris MacKenzie would like to consider a ¼ cent tax increase similar to Measure C to generate revenue for the City.

The Committee requested a status update on the priority revenue initiatives the Council identified in February 2020 at the next meeting.
