F. **GENERAL BUSINESS**

Recreation Coordinator Kendric Baccei's presentation on Special Event F.1. **Programming**

Recreation Coordinator Kendric Baccei provided an update on special event programming since the beginning of the COVID-19 pandemic. In accordance with state guidelines, all in-person events have been cancelled since mid-March; to continue programming for the community, staff pivoted and created virtual events. Highlights of the Virtual Magic Show, Virtual Movie Night, and Virtual Storvtime were presented as were the upcoming programs Letters to Santa and Socially Distanced Photos with Santa.

F.2. Discuss and provide direction on potential development of a memorial/sponsorship policy for Parks & Recreation Facilities

Deputy Director of Parks and Recreation Katie Gauntlett Reviewed Policy 5.11, the Community Facilities Naming Policy. This policy was issued in March of 2000 and a discussion was held regarding the need to revise and update this document.

Assistant City Manager Jessica Deakyne clarified procedures around an ad hoc committee. Commissioner Lacey agreed to join Commissioners Pouteau and

The committee will examine what other agencies have in place for memorial/sponsorships, methods to defray costs, ideas for generating funds to maintain facilities, and will present their findings at future meetings.

G.1. Staff Updates


Assistant City Manager Deakyne provided an update on the budget cuts approved by Novato City Council in September and the staff changes to the Parks, Recreation, and Community Services Department and Katie Gauntlett was introduced as the new Deputy Director of Parks, Recreation, and Community Services after a successful internal recruitment.

Deputy Director of Parks and Recreation Gauntlett provided an update on the community garden. She explained that staff and consultants are working to complete the Mitigated Negative Declaration as required by the California Environmental Quality Act. Document review is planned for mid-2021, and presentation for final adoption is anticipated for summer or early fall, 2021.

Commissioner Crow asked that Live Well Novato remain informed of the status of the community garden.

One of the City Engineers will be invited to a future meeting to talk about a timeline for completion of the community garden.

G.2. Commissioner Reports



Deputy Director of Parks and Recreation Gauntlett shared that her team is developing touchless marketing strategies for promoting Novato's parks and programs, which will be shared at a future meeting.

Assistant City Manager Deakyne announced that in 2021 there will be a focus on marketing to get more people involved in the commission meetings.
