### **D. PUBLIC COMMENTS**

Ed Schulze wanted to comment as a member of the public regarding the Rowland overpass based on the publicity and the fact that it has been brought up in previous meetings; would like updates on the repave/restripe.

There were 2 attendees from the public including Susan Wernick who attended regarding Thad Anders request concerning Virginia Ave.

Thad Anders spoke and said Mary Jo has reached out to him and told him a traffic study would be ordered, but he has not heard back yet. He realized closing Virginia Ave may not be realistic, but he thought a sign could be placed that reads closed to through traffic to assist in eliminating excess vehicles speeding. The outcome is pending, and a final determination will not be made until after Mary Jo has had an opportunity to do a thorough investigation.

#### E.1 Review and possibly vote on approving the draft Annual Report

#### E.2: Receive update on resident's request to block Virginia Ave to Vehicular Traffic

Gosia read Mary Jo's response and the status of her investigation. As well as the initial request that came in from Thad Anders regarding his concerns with speeding on Virginia Ave and his wish to close Virginia Ave to through traffic.

Paul said there are two issues, a barrier and speeding. The committee would like an update to the outcome after Mary Jo has had an opportunity to finish her investigation. Meherdad asked if there are other speed calming measures or policies that the city has in place. We don't but have installed rubber speed humps on Davidson as an experiment. The fire dept has historically not liked speed bumps due to the damage it can cause to their vehicles. What are the other options for traffic calming, do these need to be explored? Paul said we tend to focus on infrastructure but should consider enforcement and education as key parts of the solution.

### E.3: Receive Updates on Solutions for Intersection Redwood Blvd/Hill Rd.

Chris Blunk talked to Marin Transit and they suggested changing the route and location of stops. The Clinic no longer creates people crossing due to the relocation of the stop. It solves the immediate problem-but we will keep that location in mind for future improvements. Red curbs were also added near the entrance/exit to help eliminate parking therefore improving visibility as cars are coming into and pulling out of the lot.

#### E.4: Review and Discuss 2015 City Satisfaction Survey

The survey is now posted on the City's website for review; not certain when the next survey will take place due to budgetary constraints. Smaller surveys take place throughout the year and signing up on the city's website will keep you informed.

#### E.5: Discuss Opportunities to close streets to vehicular traffic

Similar to the Grant Ave closure; are other opportunity's available? Gosia read Mary Jo's report. Some comments include temporary street closures are more feasible and allow for experimentation and consist of moveable barriers prohibited all vehicle access, they can also be set up with signs allowing local traffic only.

Thought there might be opportunity to get more value from our streets more outdoor spaces for business and or events on the weekends. Should they reach out to the chamber of commerce or DNBA to look into this and potential opportunities? Closed to allow restaurants to serve outdoors during pandemic and was temporary. Meherdad said he would reach out to the locals' entities responsible for the oversight and report back
