A. CALL TO ORDER

E. GENERAL BUSINESS – NO PUBLIC COMMENT

E-2: DISCUSSION ITEMS:

E-2.1: FINANCE ACTIVITES UPDATE – Finance Director Amy Cunningham

 FY 18/19 CAFR STATUS – The CAFR will be presented to the City Council on 2/9/21. There has been a challenge with the calculations on the fund balances but staff and auditors are working through it. The General Fund does have a surplus and the auditors and consultants are finalizing the numbers. There are a number of audit findings including some areas that were concerns in prior years. Examples include concerns that there are too many credit cards issued to employees and the total number of cards needs to be reduced. Finance needs to set up a purchasing process to facilitate employee purchases at frequently used local vendors. This will reduce the need for individual employees to have credit cards. There is also a recommendation to change the accounts payable, positive pay, process to strengthen financial controls. Staff has already started to implement these changes.

Findings have also been issued regarding a lack of reconciliation of Cost Recovery Developer Deposit accounts, dating as far back as 1978. These funds were originally on deposit for services like inspections, engineering costs and consulting fees associated with various permits.

One of the final items needed to conclude the audit is receiving responses from the various legal firms the City uses to identify any pending litigation or other claims that may be serious enough to impact the City's financial status. To ensure continuity and assist with the FY19/20 audit, the auditors have recommended that the City retain the existing consultants.

- FINANCE RECRUITMENTS Staff has hired two
 permanent full-time employees. MarLee Castellucci and
 Polo Lopez Carrasco are the two new Accounting
 Assistants. A temporary employee has also been brought on
 to assist with the finance backlog. There are currently two
 vacancies: Senior Accountant and Management Analyst.
- REPORTING REQUIREMENTS There are a number of overdue reports to county and state agencies as well as debt reporting mandates. The new staff members will be helpful in addressing this backlog. To date, staff has been successful in working with the various agencies to obtain extended deadlines or has provided the best information currently available.
- TOT HdL has implemented the Measure Q TOT rate change. Staff will know more about impacts on revenue collections in a few weeks.

E-2-2: REVIEW AND DISCUSS FY 2021/22 BUDGET SCHEDULE AND OPTIONS FOR COMMUNITY INPUT

Staff presented the draft budget calendar for the FY2021/22 budget development process. The mid-year budget report for FY2020/21 is tentatively scheduled for late February, but that date may be delayed depending on progress to complete the FY18/19 CAFR.

Committee member Cris MacKenzie asked about updating the budget quarterly rather than one or two times per year. Finance Director Amy Cunningham stated that legally the City is required to have an annual budget and it is a best practice to review and provide quarterly updates on the budget. When staffing is stabilized and the backlog of work is addressed, quarterly budget reports will be a priority.

Staff would like to receive community input through Zoom workshops prior to the April City Council budget discussion. In person workshops will likely not be possible this year due to the pandemic. The online survey format to solicit budget feedback worked well last year and will be replicated this year. Staff is exploring options for additional and/or expanded surveys.

Chair Rafelina Maglio asked about gathering input through Facebook. Committee member Tim O'Connor suggested workshops on specific topics. Vice Chair Mark Milberg suggested that each district could hold a meeting to provide budget input.

PUBLIC COMMENT REGARDING REVIEW AND DISCUSS FY 2021/22 BUDGET SCHEDULE AND OPTIONS FOR COMMUNITY INPUT – NO PUBLIC COMMENT

F. COMMITTEE / STAFF COMMENTS

Staff advised that agreements with all bargaining units will expire on June 30th. Planning for labor negotiations is underway.

Chair Rafelina Maglio stated that the CAFR is a priority over working on the Measure F report at this time. Vice Chair Mark Milberg asked if there are leasing opportunities related to City owned buildings in the downtown area. Chair Rafelina Maglio requested an update on the revenue initiatives, including the solid waste franchise fee and commercial cannabis. Finance Director Amy Cunningham stated staff continues to explore the solid waste fee but does not have a current update.

Several responses to the requests for proposals on commercial cannabis were received.

Committee member Tim O'Connor suggested preparing a business continuity plan so that staffing turnover does not have such a detrimental impact on Finance department operations in the future. Committee member Cris MacKenzie stated that it is critical the right financial policies be put in place.
