# F.1 Receive an update from San Marin & Novato High School's Gay/Straight Alliance Group on Pride Month events.

The commission received an update from Wesley Fink and Derek De La Cruz from San Marin and Sonja Fish from Novato High on the Pride month events and presented a draft Proclamation for discussion, recognizing Pride Month in June. The students presented their event ideas to the Commission and discussed social media campaigns.

Suzanne Ford, President of the SPAHR Center and Vice President of San Francisco Pride, spoke during public comment and shared her appreciation for the work the students have done to promote Pride Month and the importance of it to the community. Ford also shared with the commission that 3/31/21 is Transgender Day of Visibility and that the San Francisco Pride Flag will be flown at City Hall. The Commissioners also expressed their support and thanked the students for their work on the event.

Commission Action: Upon motion by Commissioner Osotio and seconded by Vice Chair Jacobs, the Commission voted 5-0-2 to present the Proclamation to City Council.

F.2 Discussion to be led by Commissioner Sato regarding potential action condemning the increase of hate crimes against people of Asian descent.

Commissioner Sato suggested that the Multicultural Advisory Commission issue a joint statement with the City, condemning acts of violence directed towards Asian Pacific Islanders and their communities. Commissioner Sato added that discussions that promote diversity need to take place at home, schools, and places of warship. The Commissioners discussed with ACM Deakyne how they can issue a timely statement condemning hate on social media.

Commission Action: Upon motion by Chair Olmanson and seconded by Vice Chair Jacobs, the Commission voted 5-0-2 for City staff to issue public comment on behalf of the Multicultural Advisory Commission supporting Mayor Eklund's statement read at the City Council meeting on 3/23/21, condemning acts of violence against Asian Communities.
