D. PUBLIC COMMENTS

Gosia read an email that was received from Jim Malaspina regarding what he feels is an ongoing safety issue at the intersection of Alameda del Prado crossing Alameda del Prado. An update can be provided at the next meeting.

Dave Stabenfeldt residents on Oak Grove Drive would like the City to consider a crosswalk at Elmview Way and Oak Grove Drive as well as a stop sign allowing people to safely cross. He questioned the 25 MPH speed limit as it is not a thoroughfare; he feels it is too fast. Is it possible to reduce the speed limit?

Peter Chuck: his observations / he sees a great deal of speeding and irresponsible driving; speeding is his biggest concern. Can we confirm that speed humps / tables are not an option?

John Dicochea spoke on behalf of the Novato Fire District regarding speed tables and the reduction of response time and how they are not the first choice to reduce speed in some neighborhoods.

Thad Anders wanted to thank the committee for listening to the community and thought this might work on Virginia Ave.

Pat Eklund thanked staff for responsiveness. She had a question to John about the response time regarding Ignacio Fire Station.

Dave Stabenfeld: he is in favor of temporary closure and would like the City to consider the addition of Stop signs.

Mertle McCowen agrees with the suggestions and is in favor of what has been discussed.

Fenton Webb said he drives a Tesla and the car's navigation system tells him the speed limit is 30 then changes to 35 mph, not the stated 25 mph. He is in favor of speed tables and feels there are some crazy drivers. He believes the sign on the freeway listing Entrada Drive is part of the problem.

Peter Chuck would like to see the City institute something simple; he feels an al- way stop sign at intersection would be most helpful

Chris Blunk provided responses to the comments and justifications as to why certain solutions may not be applicable in this location.

The committee members weighed in with their feedback on the discussed solutions.

There are no new updates, but Mary Jo is in contact with residents at three different locations: Alameda del Prado at US 101, Bolling Drive and Bolling Circle as well as Bolling Drive at March Field Ct.

E.3 Receive Update on proposed new CIP Projects in Fiscal Year 2021/22 Budget Chris discussed the preparation of both the operating and CIP budget for FY 21/22; he is working with finance director, Amy Cunningham to bring it forth for discussion at various committees. Proposed budgets start in Feb and March, with the budget adoption expected in mid to late June.

Chris spoke about some of the new and upcoming projects that can be anticipated in the next fiscal period.
