H. GENERAL BUSINESS:

H.1. Review of Department Activity and Citizen Complaints Filed Since Last Meeting (Chief McCaffrey)

- One complaint filed in August was closed in December. The allegation was for performance, conduct, bias in an investigation and failure to activate a body camera during criminal investigation. Only the failure to activate body camera was sustained.
 - A performance notice was issued to the officer who did not activate their camera. The incident was not egregious and did not occur during Use of Force.
 - Unholstering of weapons automatically activates cameras, otherwise cameras are officer-activated.
- 2020 Use of Force report will be included with the end of year reporting. Some items from the report to be distributed in March include:
 - There were 10 individual Use of Force incidents: 4 taser, 4 controlled hold, 2 personal weapons (bodily, not firearm), and 2 deployments of BOLA Wrap

- PD's annual awards ceremony will be virtual. PARB members are invited
- 4 vacancies will be filled in the near future. Three by people currently going through background checks. One will soon graduate from the Police Academy. Recruitment for Police personnel is ongoing.
 - 2 officers are off work due to injury
 - 1 officer is planning to move out of state

RESOLUTION NO. 72-07

RESOLUTION RESCINDING, AMENDING AND RESTATING RESOLUTION NO. 115-05 AND RESTABLISHING A POLICE ADVISORY AND REVIEW BOARD TO REDUCE MEMBERSHIP FROM SEVEN TO FIVE

WHEREAS, the City of Novato created the Police Advisory Review Board by ordinance in August 1992, to advise on Police Department policy and appeals to investigate citizen complaints; and

WHEREAS, the City Council of the City of Novato has determined that in general City Boards and Commissions should be established by resolution, providing more flexibility to chance asnests of the enabline legislation and administration of the boards; and

WHEREAS, the reasons and justifications for establishing the Police Advisory and Review Board remain the same as those articulated by the City Council when it adopted the ordinance establishing the Police Advisory and Review Board; and

WHEREAS, by Resolution No. 43-00, the City Council reestablished and continued the Police Advisory and Review Board; and

WHEREAS, the City Council has determined that it is in the best interest of the City to increase the number of Board Members from five to seven (Resolution 112-02); and

WHEREAS, at the September 13, 2005 City Council affirmed that the Committee could meet on an "as needed" basis.

WHEREAS, at its May 14, 2007 Workshop, the City Council directed the staff to prepare and bring back for Council consideration those documents necessary to decrease the number of Board Members from seven to five.

NOW, THEREFORE BE IT RESOLVED, the City Council of the City of Novato does hereby resolve that: Resolution No. 115-05 is hereby rescinded, amended and restated in its entirety to read as follows:

Police Advisory and Review Board

Created and Defined.


The Novato Police Advisory and Review Board is created and reestablished. The term "Board" shall refer to the Novato Police Advisory and Review Board.

PURPOSES & OBJECTIVES

- Act as a liaison between the community, the Novato Police Department and the City Council
- To hold hearings and conduct investigations on citizen's complaints concerning specific programs, policies and procedures of the Police Department and to make recommendations concerning these to the Chief of Police.
- To make recommendations to the Police Chief regarding programs to encourage preservation of life and property.
- To make recommendations to the Police Chief regarding policies, programs and projects that improve delivery of police services to the Novato community.
- To conduct investigations into Citizen Complaints referred by the City Manager
- To provide an annual report after July 1st of concerning the activities of PARB



PRIOR REVIEW OF THE CAROTID MANEUVER: MAY 9TH, 2019

- It is not a choke hold, which involves restricting air. The Carotid Maneuver involves using the crook of the arm placed around the neck of a perpetrator, thus cutting off blood supply to make them lose consciousness. The maneuver is controversial, but the Court of Appeals currently supports it as a normal procedure.
- Use of force experts teach a 12-hour training course on the maneuver with a 4-hour annual refresher.
- NPD's policy is to prohibit the Carotid Maneuver except in deadly force situations when absolutely necessary because there are many other tools that can be used, including: Taser, Extended Batons and bean bag rounds.





PRIOR REVIEW OF SB 1421: MAY 9TH, 2019

- Senate Bill 1421 Effective January 1, 2019, SB 1421 requires the disclosure of records and information relating to specific types of incidents. No records currently exist for the Novato Police Department that meet the criteria detailed in SB 1421 (Penal Code Sections 832.7 & 832.8).
- Transparency tab on NPD website shows statistics, reports, policy and procedure manual, and any items related to SB 1421 would be there, too.





PRIOR REVIEW OF POLICY 1021 LEXIPOL: NOVEMBER 14TH, 2019

- Changes made may result in non-policy procedures, including loss of indemnification.
- PARB's Policy exists separately from the complaint policy and has its own Bill of Rights, restrictions and legal responsibilities.
- PARB's complaint process includes policies for the timeframe of complaints, dispute resolutions and challenging complaints. The process as it stands has worked.
- The City prefers to use a working system that holds people accountable.





PRIOR REVIEW OF DEPARTMENT STATISTICS: MAY 9TH, 2019

- Novato's community is 66.8% white. NPD's staff is 74.8% white. 19.1% are Hispanic.
- NPD has 61 officers, 9 of whom are women. Of those 9 women, 2 are Sergeants and 2 are Lieutenants.
- The average age of staff at NPD is 46.
- The average number of years on the job is 4.
- 31 of the 61 officers live 30 miles or more outside of Novato.
- 38 of the 61 have attained at least a Bachelors and four have a Masters.





CITIZEN COMPLAINTS: FY 2019/2020

- Complaints 7/1/2019-6/30/2020:
 - 6/19 Excessive Force: Unfounded
 - 9/19 Discourteous Conduct: Unfounded
