F.3. Commission Training Refresher, Laura McDowall

F.4. Discuss PARB's Annual Report Presentation to Council on July 27, 2021

It was discussed by the Board that they would present their Annual Report on PARB to the City Council on Tuesday, July 27, 2021. It was relayed to the Board that Community Outreach Liaison, Lauren Grant, from the Police Department was busy creating the presentation for the Council meeting. Grant will be updating the presentation to include activities that PARB was involved in during 2020, along with updated 2020 statistics from the Police Department. There was general consensus to have Chair Medigovich present the report to Council and she will work with Assistant City Manger Deakyne and former Chair Bartel in advance of the meeting to prepare.

F.5. Review of Department Activity and Citizen Complaints Filed Since Last Meeting (Chief McCaffrey)

- One complaint filed in the first guarter of 2021
 - Involving one employee and an accusation of inappropriate behavior
 - Disposition was unfounded based on body cam video evidence from the officer and a witness officer
- One Use of Force in the first quarter of 2021
 - Uncontrolled takedown
- Four current vacancies at the police officer level and one vacancy at the sergeant level
- Four currently in the Police Academy and three in the Field Training Program
- Newly promoted Captain Sasha D'Amico will be introduced at the next in-person meeting
- Board Member Ritter requested an updated organizational chart

G. 1. Board Member Reports

Board Member Bartel attended the School and Law Enforcement Partnership Meeting on June 2, 2021. Discussions were based around gun safety collaborative, school services updates, and the school site vaccinations. Board Member Bartel also participated on the Community Oral Board panel for the Novato Police Captain promotion.

G.2. Staff Liaison Report

Assistant City Manager Deakyne introduced the new Human Resources Manager, Jessica Collins, who will be taking over as the new staff liaison to the PARB. ACM Deakyne also introduced Management Analyst, Greg Canfield, who will be in charge of taking minutes and publishing agendas for the PARB. Both Collins and Canfield introduced themselves to the Board. ACM Deakyne made the Board aware that the City is still waiting to make a decision on whether the next PARB meeting will be in person. The Board and community will be noticed as soon as a decision is made.

Future Agenda Topic: HR Manager Collins brought up the future topic of updating police job descriptions to be in line with newly passed Assembly Bill 846.
