F. PUBLIC HEARING

Conduct a public hearing and consider adopting a resolution recommending the City Council approve amendments to Chapter XIX (Zoning) of the Novato Municipal Code involving the repeal and replacement of Sections 19.34.030 (Accessory Dwelling Units) and 19.34.031 (Junior Accessory Dwelling Units) and modifying the sections listed below as required to comply with California Government Code Sections 65852.2 and 65852.22 and finding the amendments to be exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15282(h). Other Zoning Ordinance sections referenced to accessory dwelling units and junior accessory dwelling units recommended to be amended:
