F. **GENERAL BUSINESS**

F.1. Receive a Review of the Comprehensive Fee Study from Polo Lopez Carrasco, City of Novato Accountant II and Terry Madsen, ClearSource Financial Consulting

Accountant II Lopez Carrasco provided an overview and explained that the 2019 fee study started in response to the City Council's recommendation that user and regulatory fees be periodically updated and reviewed to ensure that the City's fiscal goals are being met. The study was significantly delayed due to the pandemic, staff turnover, and other priority projects that needed to be addressed. The last Comprehensive Fee Study for the City of Novato was completed almost ten years ago.

Page | 2 Phone No. (415) 899-8900 Fax No. (415) 899-8213 Financial Consultant Madsen provided background information on the approach to user and regulatory fee studies, detailing cost of service methods and examples of potential user fee and cost recovery policies. The findings presented included a focus on the City's current cost recovery performance and general comparison of the City's existing and proposed fees with other Cities in the region, as well as variables to consider when making comparisons.

Financial Consultant Madsen shared the overall recommendations and requested action specific to departmental fees including Public Works engineering, Community Development planning/building fees, as well as recreation and facility rental rates and other administrative fees.

Committee Action: Upon a motion by Vice Chair Milberg and seconded by Committee Member Devine, the Committee voted 6-0-0-1 to support the Comprehensive Fee Study methodology of 100% full cost recovery where feasible, including a periodic inflationary adjustment.

F.2. Update from the Ad Hoc Committee for Fiscal Sustainability

The Ad Hoc Committee reported that they will focus on comparing a specific service provided by the City of Novato with the same service provided in both Petaluma and San Rafael. By comparing individual pieces of each City's expenses, patterns will be identified and used to put together a big picture analysis. The Ad Hoc Committee also proposed scheduling a review and discussion of the City's 2014 Fiscal Sustainability Plan at the September meeting.

The Ad Hoc Committee will continue to provide updates at future meetings.

F.3. Update on Finance Department Activities by Staff Liaison, Amy Cunningham

Staff Liaison Cunningham provided multiple updates.

Measure F: The department is halfway through collecting the data; once completed, the data will be embedded into the presentation and reviewed by the Committee at the September 16th meeting. The report is scheduled for presentation at the October 5th City Council Meeting.
