Chief Matt McCaffrey introduced newly promoted Captain Sasha D'Amico.

F.2. Discussion of Peace Officer Job Description Adjustments to Comply with AB846

City of Novato Management Analyst, Greg Canfield, presented on Assembly Bill 846 (AB846) passed by Governor Newsom on September 30, 2020. AB846 directed local municipalities to review their peace officer job descriptions to deemphasize paramilitary aspects of the job and to emphasize community policing. Management Analyst Canfield relayed that all sworn police officer job descriptions for the City of Novato had been amended to coincide with AB846. PARB Board Members reviewed the proposed amendments to the job descriptions. Job descriptions are scheduled to be presented to Novato City Council at their regular meeting on Tuesday, September 14, 2021 for their approval.

F.3. National Night Out Recap

Chief Matt McCaffrey reported on the National Night Out event held annually by the Novato Police Department. The event was held on Tuesday, August 3, 2021. The event was held on Machin Ave. outside of the police station. Approximately 150 community members attended. Local community businesses and the Novato Fire District participated in the event, as well.

F.4. Review of Department Activity and Citizen Complaints Filed Since Last Meeting (Chief McCaffrey)

- One complaint filed since the previous meeting
 - Involving one employee and an accusation of bias and misconduct
 - Disposition was unfounded based on body cam video evidence from the officer
- Four officers recently graduated from the Police Academy and have transitioned to the Field Training Program
- Four police officer trainees are currently attending the Police Academy
- Three officers are currently out due to injury

Board Members asked about/commented on the following topics and Chief McCaffrey responded to all:

- School Resource Officer program in Novato
- Is it necessary for officers to run all lights during standard traffic stops
- Clarification of the organization chart and location of the Community Services Officers
- Clarification of National Night Out and what the community members were interested in talking about
- Training possibilities based on the citizen complaint discussed earlier by Chief McCaffrey
- Explanation of the department being more proactive vs. reactive
- How body cam footage is utilized
- Discussion of police department data and how it is collected and disseminated
- Requested the SROs present to PARB when available
- Requested body cam and car cam presentation when available
