Meeting held via Zoom Teleconference

A. CALL TO ORDER AND ROLL CALL

E. STAFF UPDATES

E.1 Review of City Council Commissions, Committees, and Boards

- Director Blunk thanked Committee members for their volunteer efforts and commitment to cleaning and greening the City. He also acknowledged that every piece of trash picked up or median island maintained by a volunteer takes pressure off the City's Public Works maintenance division, which is already stretched thin.
- Director Blunk provided the rationale and background to the current City Council Commissions, Committees, and Boards review process, which provides an opportunity to ensure alignment with Council goals and efficient use of staff resources.

- As discussed at the November 2021 Streetscape Committee meeting, as part of the review process there is an opportunity to explore whether a Council Committee is the most efficient and effective structure given that the activities and projects undertaken by the Committee are more consistent with a hands-on volunteer group.
- Blunk noted that the Committee does not currently serve in an advisory capacity to the City Council, as is the case with most other City Commissions, Committees, and Boards, and that it is rare for members of the public to attend Committee meetings.
- Committee members and City staff discussed options to provide ongoing support for the Committee's volunteer efforts in the community while allowing for more autonomy and less constraints.
- The discussion will be continued at the January 10, 2022 Committee meeting, prior to a recommendation going to the City Council on January 25, 2022.

Moved by Hanna and seconded by More, that Committee members will continue to work with City staff to explore options to efficiently and effectively support the Committee's volunteer efforts in the community.

- Blunk noted that business sponsorship of Redwood islands is an option as long as maintenance activities go above and beyond the basics provided by City staff.
