ZONING MAP AMENDMENT; P2021-050

TENTATIVE MAP; P2021-101 DESIGN REVIEW; P2019-003

CEQA EXEMPT: CEQA GUIDELINES SECTION 15183

200 SAN MARIN DRIVE; APN 124-282-18

Public hearing and possible action to adopt resolutions recommending the City Council: (1) adopt findings and determine that no further environmental review is required pursuant to California Environmental Quality Act (CEQA) guidelines section 15183; (2) approve a zoning map amendment to change the zoning of the subject parcel from Planned District (PD) to General Commercial (CG); and (3) approve a design review and tentative map for Comstock Commons, a 6 unit live/work project proposed at 200 San Marin Drive, APN 124-282-18

Planning Manager Marshall introduced the item and requested the Planning Commission take public comment on the proposal and continue the matter to February 14, 2022. Planning Manager Marshall explained that staff wanted additional time to add two conditions of approval omitted from the staff report package, as well as an opportunity to update the staff report with additional information regarding the project site's past use as a gas station.

Vice Chair Tiernan opened the public comment period.

Carrie Ford noted she live adjacent to the project site and raised questions regarding the soil sampling and excavation for the project, as well as asked for clarification regarding the function of a live/work unit.

Vice Chair Tiernan encouraged Ms. Ford to review the staff report.

Planning Manager Marshall noted the staff report would be updated to provide more information about measures addressing the site's past use as a gas station. He also explained the operation of a live/work unit.
