F. GENERAL BUSINESS

F.1. Receive a presentation and consider implementing a Pilot Rotational Play Policy at the Hill Recreation Area Pickleball Courts from Recreation Supervisor Kendric Baccei

Deputy Director Gauntlett provided an overview of the topic and stated the department utilized email and social media outreach to inform the discussion topic. Along with signs at pickleball courts and City Hall.

Recreation Supervisor Baccei presented a history of the Hill Recreation Area and it's pickleball courts. The pickleball courts are open to all community members, resident & non-residents alike, and do not require reservation to play. Individual pickleball courts are not designated for any one skill level and welcomes all levels of play.

Recreation Supervisor Baccei shared she receives community feedback about long wait-times, interest in rotational play for the pickleball courts as well as individuals looking for new partners to play with. Staff have explored the concept of rotational play from other agencies, spoken to the pickleball community and are recommending a pilot use policy implementing rotational play for the summer months to meet the community's requests.

Recreation Supervisor Baccei provided an example of rotational play for the pilot policy. Rotational play would begin when all six courts are in-use, and one or more players are waiting to play. The courts would utilize Paddle Racks, one for each

court, to be used to guide the flow of play by indicating the next group of players waiting for an open court. A Paddle Rack is a convenient paddle holder, designed specifically for the game of pickleball, that attaches to fencing and provides organization of which player is next in line to play.

Recreation Supervisor Baccei shared Pickleball games are played to eleven points and players should play one game before rotating off the court for the next set of players. This policy would apply to either singles and doubles games. Rotational play at the Hill Recreation Area Pickleball Courts would provide members of the community the ability to participate at a faster rate and in turn reduce wait times for courts.

Recreation Supervisor Baccei stated that staff are recommending that this Pilot Policy be implemented after hosting an in-person community workshop in June and be carried out through August 2022 to allow staff time to evaluate the changes and collect community feedback. Staff will then return to the RCCS Commission at their scheduled meeting in September with the analysis of this Pilot Policy and a recommendation for next steps based on findings.

Commissioner Weber asked a question if this system of play is used in other cities. Recreation Supervisor Baccei shared it is utilized in other cities.

Chair Ricketts asked for clarification on rotational play and when it's in use. Recreation Supervisor Baccei confirmed it would only begin when all courts are occupied.

Chair Bentley asked how this would work if a court was rented. Deputy Director Gauntlett noted the priority use for the courts and if somebody has a reservation, they have the court. Recreation Supervisor Baccei mentioned all reservations are noticed at the courts indicating which are reserved.

Vice Chair Lacey asked if lessons or reservations of courts are taking up peak hours for the pickleball community and if the City has considered making reservations unavailable at peak times. Deputy Director Gauntlett stated the City has explored this however rentals are typically during peak hours.

Commissioner Erickson asked if the Commission was being tasked with considering changes to the court rentals. Deputy Director Gauntlett clarified that staff is asking the Commission to consider the pilot and proposal for rotational play during the summer months of June through August.

Commissioner Bentley asked about priority use for Novato residents with the pickleball courts being used by a variety of people in the area. Deputy Director Gauntlett noted the courts draw a lot of interest from players around the Bay Area. However, implementing priority use without a facility attendant is not feasible.

Chair Ricketts asked if staff have considered dedicating courts based on level of play. Deputy Director Gauntlett noted staff have considered that idea but it would be extremely difficult to manage as players may have different opinions on their own level of play thus leading to potential conflicts.

SUBJECT: ESTABLISH GUIDELINES & PROCEDURES FOR A COMMEMORATIVE

BENCH SPONSORSHIP PROGRAM

REQUEST

Consider establishment of a Commemorative Bench Sponsorship Program.

DISCUSSION

The City of Novato Parks, Recreation and Community Services Department (PRCS) would like to establish a standard protocol for accepting charitable sponsorships to replace existing benches in City parks and along trails. The ability for individuals and groups to honor a person, show gratitude for our parks, or commemorate a special moment. This benefits Novato residents while also contributing to the aesthetics and accessibility of public areas.

Individuals frequently contact PRCS with requests for donations to our park system & the RCCS Commission directed staff to explore establishing a formal sponsorship program. There is presently no formal policy or program in place in Novato to handle these types of requests. Responsibility for maintenance, installation location, life and costs for the bench, plaque standards and bench criteria will be addressed in the established community bench sponsorship program. The ultimate goal is to create a program that is adaptable and responsive to the requirements of our community's donors while also supporting the City's parks and trail system.

The following are general PRCS guidelines for the Commemorative Bench Sponsorship:

- 1. Benches are currently the only items that can be donated.
- 2. Donors are responsible for costs associated with purchase, plaque and installation of bench.
- 3. The City will make every effort to accommodate the installation location requested. Park benches in need of replacement, and qualified for sponsorship, are determined by the PRCS Director or their designee. Once a bench has been identified for sponsorship, PRCS staff will add its location on a restoration list.
- 4. From the date of installation, the sponsorship will remain be in place for 10 years. The bench will be maintained by Parks Maintenance employees throughout that term.
- 5. After the 10-year sponsorship period, the sponsored bench may be available for renewal, with the original sponsor having first right of refusal. If the current sponsor declines to renew their sponsorship, the bench may be rededicated or removed.
- 6. If the bench is damaged beyond repair over the 10-year term, staff will reach out to the donor to discuss replacement.

PUBLIC OUTREACH

This item is listed on the Recreation, Cultural & Community Services Commission agenda, which is posted on the City's Community Service Board and website 72 hours prior to the Commission meeting as required by California Government Code 54954(a) ("Brown Act"). It is also posted on the City's website at novato.org/councilagendas.

RECOMMENDATION

Staff recommends that the Commission authorize the establishment of a Commemorative Bench Sponsorship Program.

COMMEMORATIVE BENCH SPONSORSHIP PROGRAM GUIDELINES

INTRODUCTION

The City of Novato wishes to adopt a uniform program for accepting charitable sponsorships to replace existing benches within city parks, along trails, or public facilities. Providing individuals and organizations an opportunity to commemorate a person, celebrate an occasion, or express appreciation for parks provides the residents of Novato a public benefit as well as supports the beautification of public spaces for all.

The Commemorative Bench Sponsorship Program serves to provide guidance and consistency to those interested in sponsoring a park bench in matters pertaining to bench standards, locations, length of terms, costs, plaques, and the application process.

This program is overseen and implemented by Novato Parks, Recreation & Community Services Department (PRCS).

1. PROCESS FOR SPONSORING A BENCH

- a. Review the Commemorative Bench Sponsorship Program Guidelines.
- b. Download and complete the Commemorative Bench Sponsorship Program Application.
- c. Submit completed applications via email to <u>novatofun@novato.org</u> for review.
- d. PRCS staff will be in contact with applicant.

2. <u>BENCH STANDARDS</u>:

The City of Novato Public Works Department and Parks, Recreation & Community Services Department have a desire to standardize the sizes and style of benches installed throughout the park system to the greatest extent possible, to reduce costs associated with obtaining and/or maintaining a large stock of diverse replacement parts or hardware, as well as supporting overall beautification and accessibility of the spaces. The PRCS Department works closely with the Public Works Department on these standards and identifying products that meet these needs on an ongoing basis.

Benches become property of the City of Novato once they are installed. The City will maintain the bench for up to 10 years.

A standard park bench model for sponsorship has been selected based on its maximum longevity, environmental considerations, aesthetics, and maintenance liability. The standard park bench is represented below, although exact models may be subject to change.



A standard park bench is 6 feet long and can be put on the ground or surface mounted, depending on the area.

When a park site and/or recreation facility is carrying out a particular theme, or is intended for specific use, the theme or use may be considered for the selection of an alternate park bench.

Bench donations commemorating commercial products, political parties, activist groups, or non-profit corporations involved in lobbying at any level of government, for profit corporations, or memorials containing endorsements of products or services, or that otherwise may be construed to be advertising or commercial promotion are prohibited. It is forbidden to paint, stain, or lacquer the benches. All park benches are maintained by Parks Maintenance Staff or qualified contractors.

3. COST AND LENGTH OF TERMS:

Sponsorship of a bench includes the cost of the bench, a plaque with inscription, installation, and maintenance for 10 years. The applicant will cover these costs apart from maintenance responsibilities over the lifetime of the bench (10 years).

Benches become property of the City of Novato once they are installed. The City will maintain the bench for up to 10 years. The City guarantees maintenance of the bench by Parks Maintenance staff or qualified sub-contractors. If the bench is damaged beyond repair over the 10-year term, staff will reach out to the donor to discuss replacement.

When the bench reaches its 10-year term, the donor will have an opportunity to initiate a new agreement for a second ten-year term and pay the cost of the new furnishing, and installation, or have the plaque removed and returned at no cost to the donor. If the donor chooses to renew the bench dedication after its initial 10-year term, the donor will need to submit a new agreement and provide payment for the new bench.

4. INSTALLATION & LOCATION:

If the donor has a desired installation location for the bench, the City will work with the donor to try to accommodate the requested installation location. The final decision, however, regarding

location and placement must be consistent with our parks policies, and approved by the Director of Parks, Recreation and Community Services (PRCS), or their designee.

The City of Novato retains the right to relocate a park bench at any time. If the bench needs to be relocated, PRCS will attempt to contact the donor to discuss an alternate location. The PRCS Director, or their designee, will make the final determination for the bench's location.

5. PLAQUES STANDARDS

Plaques installed on sponsored benches must be for an individual or a purpose that is non-controversial with text that is appropriate for display in a public place and approved by the PRCS Director, or their designee. The recognition will be regulated, styled, and handled in a tasteful and consistent manner, as determined by the Department of Parks and Recreation.

Text that in any way markets a product or service shall not be permitted. The City of Novato will not pay for the replacement of damaged plaques. A new replacement plaque may be purchased. The plaque is not intended as a memorial marker and may not include birth and death dates or years. Messages should be simple statements recalling the event or person(s) recognized. The plaque is merely symbolic of the sponsorship; it does not provide the donor ownership of the bench.

6. <u>CITY RESPONSIBILITY & CONDITIONS</u>

The PRCS Department will inventory, date, and maintain a listing of sponsored benches and plaques. The City of Novato will not be held responsible if the contact information on file is outdated and the original donor cannot be contacted.

Should the name of any individual or organization honored on a plaque be considered to have acquired a negative connotation or definition, the City reserves the authority to revoke the name and plaque.

The purpose of a sponsor purchasing a park bench should not clash with the City's or PRCS Department's mission. The community should receive a positive and desirable image from the sponsorships. As a result, any entity engaged in the marketing, production, or distribution of items that are regarded incompatible with the City's goals and mission is barred from being recognized.
