Project Description:

DISH Wireless LLC proposes to collocate on an existing wireless facility site located at 199 San Marin Drive. The proposal is to install six (6) antennas (2 per sector) and twelve (12) RRUs on the rooftop. The three sectors will be concealed behind FRP screening painted to match the



existing structure and not seen from public view. The equipment cabinet and associated equipment will be installed on the ground inside a fenced area. Both power lines and fiber lines will be placed in a new cable tray on the rooftop. The cable tray will run from the equipment cabinet to each antenna location. All proposed concealment will be painted to match existing and antenna height will not exceed the height of the existing facility.

This project will help support the wireless connectivity needs of residents, businesses, and first responders in the community – needs that now are more critical than ever, especially for those consumers without access to other sources of connectivity.

Consistent with the FCC's shot clock rules, the submission of this application initiates an initial 60-day shot clock to review and approve the application. *Id.* § 1.6100(c)(2). DISH wireless may be agreeable to extending these timelines.

Notwithstanding the 60-day deadline, DISH Wireless would be willing to enter into a tolling Agreement based on the City of Novato's request for additional review time due to a specific reason and for a specific and reasonable period of time.
