E. **GENERAL BUSINESS**

E.1 Reorganization of City Administration, Including Economic Development Activities City Manager Adam McGill spoke about the reorganization of duties related to Economic Development returning to the City Manager's Office, thanked Vicki Parker for managing the department and program since 2019. McGill also introduced Alison Fletcher as the new analyst now helping with programs including cannabis, short-term rentals, and the business improvement grant program and she will report to Will's future replacement. Recruitment is open to replace the Senior/Principal Analyst who will be introduced to the Commission in the next couple of months.
