A. CALL TO ORDER AND ROLL CALL

Meeting began at 7:03pm.

B. APPROVAL OF FINAL AGENDA

Eric Rayner from Rayner Landscaping shared that he will no longer be maintaining the island on the northern corner of Redwood Blvd. and De Long Ave. or the City-owned urns/flowerpots on Grant Ave.

E. STAFF UPDATES

E.1 Finance Update

 Schubeck shared that the current balance in the fund for Streetscape projects is \$22,318. She will confirm whether the \$5,000 allocated for FY 2022-23 has already been transferred into the account.

 Joan Cortney has resigned from the Committee and the vacant position will be filled as part of the City's Commission, Committee, and Board recruitment process in the fall. The term will commence on November 1, 2022.

G.1 Education and Outreach

G.2 Volunteer Programs

Team Up to Clean Up

- The July clean-up was held along Nave Drive. Six volunteers collected seven bags of trash and spent a total of 14 hours picking up litter.
- The August clean-up was held along Alameda del Prado with nine volunteers collected four large bags of trash.
- The September clean-up will be held on Binford Road in partnership with Marin County Parks as part of Coastal Clean-up Day on September 17, 2022.
- Hanna shared that the Town of Mammoth Lakes held a large trash drop-off event with funding from a Clean CA grant.

Adopt-a-Spot

- Hanna would like to turn this program over to another Committee member.

Adopt-an-Island

- Three estimates have been received for the landscaping project on the northern corner of Redwood Blvd. at Olive Ave. However, because the work is a public works project, and the value of the work is over \$1,000, prevailing wages must be paid to all workers.
- Schubeck will prepare a Scope of Work to be approved by the Public Works Dept.
- Basalla and Temple will contact Public Works staff member Gosia Woodfin about the safety improvement project on Redwood Blvd. and De Long Ave. to discuss plans for landscaping.
- Temple shared that she has spoken with the City Manager about grant opportunities.

G.3 Business Landscape Recognition Program

Nominations

- Basalla nominated Redwood Credit Union on Grant Ave., Marin Coffee Roasters on Novato Blvd., and El Rey Restaurant on 7th Street for landscape recognition.
- Schubeck will send landscape recognition criteria to all Committee members, and Committee members will visit these sites prior to voting at the September meeting.
