UNITED AGAINST HATE WEEK NOVEMBER 13 – 19, 2022

WHEREAS, the United States is a nation of immigrants and Indigenous peoples, whose strength comes from its diversity; and

WHEREAS, the Constitution enshrines equality on all individuals, regardless of race, gender, orientation, religion or political views; and

WHEREAS, recent rhetoric has generated a toxic environment that encourages the propagation of racist, xenophobic, sexist, homophobic, discrimination based on religious beliefs and other bigoted views by emboldened hate groups and individuals; and

WHEREAS, deep divisions within our country allow for the festering of extreme ideology, further strengthening a cycle of mistrust and suspicion fueled by fear, anxiety, and insecurity; and

WHEREAS, the number of hate crimes across the United States has increased dramatically over the past couple of years; and

WHEREAS, the City of Novato City Council is dedicated to preventing and opposing hate and intolerance in our community; and

WHEREAS, the City of Novato City Council, since 2018, have participated in United Against Hate Week and Not In Our Town, and its movement to stop hate, address bullying, and build safe, inclusive, communities for all; and

WHEREAS, the Multicultural Advisory Commission is advisory to the City Manager and City Council, providing support around issues surrounding multiculturalism, diversity and hate crimes, acting as a catalyst to encourage respect, understanding and inclusion of all of Novato's diversity; and

WHEREAS, the Multicultural Advisory Commissioners joins all of our community partners in recognizing this week and bringing to light that education, compassion, and cooperation are key to unlocking understanding and embracing differences between people; and

WHEREAS, the City of Novato commends all United Against Hate Week actions undertaken by participating Novato community members, including collaborative work with North Marin Community Services, Novato Unified School District, Novato Police Department, Not In Our Town National, Marin County District Attorney's Office and Novato's Multicultural Advisory Commission to create awareness, educate, and share resources regarding how to positively respond to hate.

NOW, THEREFORE, BE IT RESOLVED, that the City of Novato seeks to join the Bay Area, California, and other communities across the country in United Against Hate Week as an important step in bridging division and strengthening our communities to combat hate.
