Board Member Drouillard mentioned that he was recently able to assist with the Sergeant panel and reiterated

that it was a worthwhile endeavor. Chair Medigovich volunteered to be on the panel.

F.5. Review of Activity in the School Resource Program

Captain Sasha D'Amico presented on the School Resource Program. Captain D'Amico discussed the NUSD Tiered Intervention Matrix. She relayed topics of school safety that has been worked on with the school district, including upcoming trainings for school personnel. She stated the status of the program staffing and that Lieutenant Chris Jacob had taken over command of the program. Captain D'Amico ended by relaying the intentions of the department, along with the school district, on how they can evolve partnerships to also include the community.

Chair Portje, Vice Chair Brizzolara, and Board Members Medigovich, Ritter, Drouillard, and Bartel provided Captain D'Amico with questions and comments. Captain D'Amico responded to all questions.

F.6. Review of Department Activity and Citizen Complaints Filed Since Last Meeting

Chief Johnson relayed that there were 5 citizen complaints since the last meeting in May. The complaints were based in discourtesy, unlawful detention, unlawful arrest, failure to perform duty and bias. In each instance the disposition was the Department and its employees operated in a lawful and appropriate manner, all complaints were exonerated. Chief Johnson also provided a department update stating that Novato PD had participated in several community events, such as, Kids vs. Cops soccer game with North Marin Community Services, the Art and Wine Festival, Rock the Block, the Special Olympics Torch Run, and the Fourth of July Parade on Grant Avenue. She also stated that Novato PD had just run a successful National Night Out event held on the Pocket Park at the Downtown Recreation Center. Lastly, Chief Johnson reported on the status of several Novato PD employees and their statuses within their specialty assignments.

Chair Portje, Vice Chair Brizzolara, and Board Members Medigovich, Ritter, Drouillard, and Bartel provided Chief Johnson with questions and comments. Chief Johnson responded to all questions.
