G. GENERAL BUSINESS

G.1. Housing Element Update Community Workshop #2

This second workshop for the Housing Element Update will provide an opportunity for the community to hear about work done to date as well as a forum for the community input on housing related ideas and concerns. During the workshop, relevant housing issues, including potential housing sites and programs that will encourage the development of new housing solutions for Novato, will be discussed.

During the meeting, the City's consultant team will be doing live polling of the audience. Director Parker introduced the Housing Element item.

Phone No. (415) 899-8900 Fax No. (415) 899-8213 Consultant Bergman reviewed a PowerPoint presentation and conducted a live polling exercise.

Commissioner Gerber – If a religious organization, private property owner, nonprofit, or agency had interest in developing housing is it too late to approach City to consider the site?

Director Parker stated she supports property owners and others reaching out to City. However, they should do so as soon as possible.

Commissioner Gerber – The average rent in Novato was noted as \$1,950 per month. Is that for a one or two bedroom unit?

Consultant Bergman – The figure is an average of all rental units – the average skews low.

Commissioner Tiernan – If a certain number of units are listed in the Housing Element have we essentially pre-approved them?

Director Parker — The approach in the Housing Element, a program document, in terms of RHNA and CEQA was to consider the pipeline projects at their maximum development level. The largest of those sites require legislative actions, so there is still room for regular decision making with the caveat that any units that are not picked-up on those sites — we will need to find additional sites at the correct density. We were very judicious about assumptions on pipeline sites with the understanding some are still in review.

Commissioner Tiernan – So when we do the site inventory there won't be as many brand new housing sites?

Director Parker – That is a fair statement. The challenge for this housing element cycle will not be sites, but programs to address renter situations. The data on rental communities shows that until 2014/15, rents in Novato were less than the county average – thereafter rents escalated and are now the same as the county average.

Commissioner Gerber – Are there newer recommended best practices based on southern California? Do we need a buffer of extra projects to cover the unpredictability of the HCD process?

Director Parker - We are assuming a buffer of 18% to 20%.

The public comment period was opened.

Madeline Kellner – One of the policies brought-up tonight addressed low barrier navigation centers. What are these centers?

Consultant Bergman confirmed Commissioner Tiernan's understanding.
