F.5. Review of Department Activity and Citizen Complaints Filed Since Last Meeting

Chief Johnson relayed that there were 4 citizen complaints since the last meeting in August. The complaints were based in bias, discourtesy, neglect of duty, and standards of conduct. In each instance, the disposition was the Department and its employees operated in a lawful and appropriate manner, all complaints were exonerated.

Chief Johnson also noted that NPD had participated in several community events such as National Night Out, Sparkle Backpack Stuffing Event, Relay for Life, the San Marin and Novato High Homecoming Parades, National Coffee with a Cop Day, National Faith & Blue Weekend, Nostalgia Days, Leadership Novato, Red Ribbon Week at Rancho Elementary, and the Good Shepherd Fun Run Event.

Lastly, Chief Johnson reported on the status of several Novato PD employees and their statuses within their specialty assignments.

Board Members Bartel, Dow, Drouillard, Medigovich, and Ritter provided Chief Johnson with questions and comments. Chief Johnson responded to all questions.
