F.3. Update on Finance Department Activities

Administrative Services Director Cunningham and Administrative Services Deputy Director Carvalho-Degraff provided an update regarding the Finance Department activities:

- The Fiscal Year 2019/2020 Audit is near completion and will be presented to City Council at the February 28th Council meeting. The audit contained a clean opinion and many findings. The findings and recommendations will be attached to the final report that will go to Council. The report will be reviewed by the FAC at the March meeting.
- Staff is starting preparation for the Fiscal Year 2020/2021 audit process. Staff is waiting for the auditors to provide a timeframe to get this audit finalized.
- Staff are also starting to prepare for the Fiscal Year 2021/2022 audit, in parallel with the FY 2020/2021 audit. One major update for FY 2021/2022 was the leaser/lease standards. The City is using Debt Book software to help with long-term lease standardization implementation.
- The Fiscal Year 2023/2024 Budget preparation is underway. Staff has been internally preparing and initial meetings with labor groups have begun.
- Many policies are in process of updates. The Credit Card and Purchase Order policies are being reviewed and updated, and upon completion, will address several of the FY 2019/2020 audit findings.
